What Is Biblical Justice? - RELEVANT

In June 2006, the same judge struck down six control orders on the basis that the Home Secretary had no power to impose 18 hour curfews without a derogation from Article 5 ECHR. In August 2006, the Court of Appeal upheld Mr Justice Sullivan's ruling on Article 5 but reversed it in relation to Article 6 (see casenote below).

Counter-terrorism and human rights - JUSTICE

The Justice for Victims of Trafficking Act of 2015 (JVTA), Pub. L. No. 114-22, again gave the Department more tools to address human trafficking, by: Adding "patronizes" and "solicits" to 18 U.S.C. § 1591(a) to facilitate prosecution of customers of sex trafficking victims.
